

**RESOLUTION R- - 2016
VILLAGE OF BOLIVAR**

A RESOLUTION DECLARING THE NECESSITY TO LEVY A TAX IN EXCESS OF
THE TEN-MILL LIMITATION

ORC 5705.19, ORC 5705.191, ORC 5705.25, ORC 5705.26

THE VILLAGE COUNCIL FOR THE VILLAGE OF BOLIVAR OF TUSCARAWAS
COUNTY, OHIO MET IN A REGULAR SESSION ON THE 4TH DAY OF APRIL,

Member Lapp moved the adoption of the following:

BE IT RESOLVED by the Village Council of the Village of Bolivar,
Tuscarawas County, Ohio that

Section 1. That the Council determines and declares that the amount of taxes which may be raised within the ten mill limitation will be insufficient and that it is therefore necessary to levy a tax in excess of the ten mill limitation for the benefit of the Village of Bolivar, Tuscarawas County, Ohio, for the purposes of providing for the current expenses of the Village of Bolivar at a rate not exceeding 1.8 mills for each one dollar of valuation, which amounts to 18 cents for each one hundred dollars of valuation and which levy is a renewal of an existing levy of 1.8 mills.

Section 2. The question of approving the levy shall be submitted to the electors of Tuscarawas County at the election to be held on the 8th day of November, 2016, in compliance with the provisions of ORC 5705.34, if a majority of the electors voting thereon vote in favor thereof.

Section 3. It is found and determined that all formal actions of the Village Council concerning and relating to the adoption of the resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in those formal actions were in meetings open to the public, in compliance with the law.

Section 4. The Fiscal Officer of the Village of Bolivar is directed to certify immediately a copy of this resolution to the Board of Elections of Tuscarawas County Ohio, and to notify said Board of Elections to cause notice of election on the question of levying said tax to be given as required by law.
